The Prayer said and the Pledge was recited.

Agenda Item 6d, "An Ordinance of the Plaquemines Parish Council acting as the Sole Governing Authority of the Plaquemines Port, Harbor and Terminal District to authorize and direct the purchase of the Popich Building from Plaquemines Parish Government; and otherwise to provide with respect thereto" was deferred.

There being no Executive Session, Commissioner Blink moved to Agenda Item 3, "Status Report by the Executive Director". Without objection, so ordered. Sandy Sanders reported the following:

- Over the past weeks there have been virtual conferences hosted by the American Association of Port Authorities, The Maritime Administration and Inland River Port Terminals to discuss best practices during the Covid-19 crisis;
- Work has continued via teleconferencing on the three Port projects covered by Non-Disclosure Agreements;
- There have been weekly virtual meetings held with the Port employees who have been working from home. He thanked Christie Nielsen, Donald Durr and Chambrel Riley for their efforts and thanked the rank in file staff for their dedicated efforts;
- He was informed by Col. Murphy of the Corps of Engineers that all the requirements of the B-3 project have been received and a summary of the D408 are in the works which will then complete the 408 process. The final permit for this project is anticipated to be issued on May 8, 2020;
- Sandy Sanders submitted of list of infrastructure projects to GNO, Inc. to include in their Master List of infrastructure projects in the event the Phase 4 Infrastructure Stimulus package is offered to the New Orleans area. The following was requested:
  - 1) New Orleans Gulf Coast Railroad realignment-\$50,000
  - 2) Peters Road Extension-\$60,000,000
  - 3) NOV NFL levee to be raised to 50-year protection status-\$200,000,000
  - 4) Requested fast tracking of needed permits for the Plaquemines Port Container Terminal (no funding requested due to private funds being used)
  - 5) Coast Guard to elevate their road in the Venice Port Complex-\$4,000,000

Commissioner Blink asked when the B-3 project began and was told by Sandy Sanders that it was in 2017. Commissioner Blink also asked if the \$60,000,000 requested for the Peters Road Extension would be enough funds. Sandy Sanders said it would cover the extension of the road over the Intercostal Canal providing another evacuation route and another means for the Port to move cargo.

Commissioner Blink moved to Agenda Item 3a, "Finance Report/Budget to Actual". Without objection, so ordered. Chambrel Riley said there was no report for this meeting; however, she will

have a Budget to Actual report for the next meeting. She went on to say that there was no negative impact due to Covid-19 in the month of March, 2020 in reference to Tariff fees and activity on the river.
